- The successful candidates are advised to deposit a fee of Rs. 5615/- (Rupees five thousand six hundred fifteen only) on or before July 28, 2010 with the Institute failing which the admission is liable to be cancelled.
- The candidates are advised to produce original certificates in support of their date of birth, educational qualifications, valid fellowship, migration certificate, community certificate for seeking reservation, etc. along with an attested photocopy thereof for verification.
- The admission is provisional and subject to verification of community certificate being verified through proper channel. If the verification reveals that the claim of the candidate seeking reservation under SC/ST/OBC/PH category is false, the admission shall be terminated forthwith without assigning any further reasons.
- **The candidates seeking reservation under OBC category are further advised to bring a certificate from a Competent Authority (SDM/Employer of the parents) regarding not belonging to ‘Creamy Layer’ of OBC together with a duly authenticated salary certificate of Father & Mother (if employed) indicating the annual total salary for past three years.**
- The admission is based on the information given by the candidate in his application and shall be considered null and void if a material error/suppression is discovered at any time.
- The admission to DBT-JRF (Category – B) shall be limited to a maximum of two, as per DBT guidelines/instructions
