### A. Staff Scientists

<u>Specialization</u>: Applicant should have a Ph.D. with excellent academic credentials along with the track record of scientific productivity evidenced by publications in the frontier areas of Plant Biology such as, Computational Biology, Genome Analysis and Molecular Mapping, Molecular Mechanism of Abiotic Stress Responses, Nutritional Genomics, Plant Development and Architecture, Plant Immunity, Molecular Breeding, Transgenics for crop improvement and other emerging areas based on plant genomics.

Remuneration: The length of experience and scientific accomplishments/quality of scientific productivity record will be major factors in deciding the level of appointment as Staff Scientist as well as starting salary in the pay bands of ₹ 15,600-39,100 (with grade pay of ₹ 5400, 6600 and 7600), and ₹ 37,400-67,000 (with grade pay of ₹ 8700) plus usual allowances admissible to the Central Government employees.
