Applications are invited from suitable candidates for filling up purely temporary position of one Senior Research Fellow/Project Associate-II in the DBT project entitled "Functional characterization of genome-edited lines for discovering novel genes regulating grain mineral contents in Indica rice", under the supervision of Dr. Hasthi Ram, Scientist, NIPGR. The details are as under:

Senior Research Fellow/Project Associate-II (One Post): Emoluments `.42000/- + 27% HRA as sanctioned in the project.

Qualification for SRF: Candidates fulfilling the eligibility criteria mentioned in the DST Office Memorandum number DST/PCPM/Z-06/2022 dated 26/06/2023 and having Master's degree in any branch of Biological /Life Sciences with 60% (or Equivalent) marks or an equivalent degree in any branch of Biological/Life Sciences with two years post-masters degree experience in research are eligible to apply. Furthermore, Candidates with experience of working with molecular biology techniques, such as cloning, RT-PCR, LC-MS, GC-MS, and/or plant tissue culture techniques will be given preference.

Qualification for PA-II: Candidates fulfilling the eligibility criteria mentioned in the DST Office Memorandum number SR/S9/Z-05/2019 dated 10/07/2020 and having Master's degree in any branch of Biological /Life Sciences with 60% (or Equivalent) marks or an equivalent degree in any branch of Biological/Life Sciences with two years post-masters degree experience in research are eligible to apply. Furthermore, Candidates with experience of working with molecular biology techniques, such as cloning, RT-PCR, LC-MS, GC-MS, and/or plant tissue culture techniques will be given preference. The upper age limit for is 35 years in case of PA-II position.

The above position is completely on temporary basis and co-terminus with the project. The fellowship amount for the above positions is as sanctioned in the project and as per DST/DBT norms. The initial appointment will be for one year or till the tenability of the project whichever is earlier and the same can be curtailed/extended on the basis of assessment of the candidate's performance and discretion of the Competent Authority. NIPGR reserves the right to select the candidate against the above post depending upon the qualification and experience of the candidate. Reservation of posts shall be as per Govt. of India norms. The appointment may be terminated at any time by giving one month notice by either side. The applicants will have no claim implicit or explicit for consideration against any regular position of NIPGR.
