Applications are invited from suitable candidates for filling up the purely temporary position of one Student Trainee under the Scientific Social Responsibility (SSR) head of SERB- SRG project proposal entitled “Characterization of PRL1 function in plant defense responses against insect herbivory”, under the supervision of Dr. Mukesh Kumar Meena, Scientist, NIPGR.

1. **Student Trainee (One Post):** Consolidated emoluments ` . 5000/- per month as sanctioned in the project.

Eligibility Criteria: Candidates currently pursuing the B.SC./B.Tech/B.Eng./M.Sc. in any discipline of Life Sciences/BS-MS dual degree with biology as a major subject are eligible to apply. **The tenure of the position is for two months and is not extendable.**

Desirable Criteria: **Experience of molecular** biology techniques, CRISPR and transformation in crop plants.

The above position is completely temporarily and co-terminus with the project. The stipend amount for the above position is as sanctioned in the project and as per norms. The appointment for the post of Student Trainee will be for two months only and tenure of the post can be curtailed based on the assessment of the candidate's performance and the discretion of the Competent Authority. NIPGR reserves the right to select the candidate against the above post depending on the qualification and experience of the candidate. Reservation of posts shall be as per Govt. of India norms. The appointment may be terminated at any time by giving one month notice by either side. The applicants will have no claim implicit or explicit for consideration against any regular position of NIPGR.

The candidate must ascertain their eligibility before applying, as ineligible candidates will not be interviewed. All the candidates are requested to appear for the interview with complete bio-data, earlier dissertation thesis, publications in copy (if any) and original degree/experience certificates and transcripts.
