नियम और शर्तें:

- Every tender shall be accompanied with the tender cost of ₹ 500/- (Rupees Five Hundred only) in the form of Demand Draft drawn in favor of "Director, NIPGR" payable at New Delhi in separate sealed envelope along with the tender. In case the tender cost is not submitted, the tender will not be considered.
- Every tender shall be accompanied with the required Earnest Money Deposit in the form of Demand Draft drawn in favour of the "Director, NIPGR" payable at New Delhi. Any tender not accompanied by such earnest money will be rejected straight away.
- 3. The rates quoted in the tender shall remain valid for a period 180 days from the date of issue of Award Letter. No tenderer can withdraw/or modify his tender or revoke the same within the said period. If a tenderer on his own withdraws or revokes the tender or revises or alters or modifies the tender for any item or condition within the period mentioned in the tender notice, his earnest money deposit shall stand forfeited. Notwithstanding foregoing, the Institute reserves the right to take other actions as deemed appropriate. In two-bid system the tenders should be submitted containing (a) Technical Bid consisting of all technical details along with commercial terms and conditions and (b) Financial Bid indicating item wise price for the items mentioned in technical bid. The technical bid and financial bid should be sealed by the bidder in separate covers duly super scribed and both these covers must be put in a bigger cover which should also be sealed and duly super scribed. NIPGR will not pay any expense, whatsoever incurred by tenderer for the preparation and submission of tenders.
- 6. The notice inviting tender, will form part of the contract agreement to be executed by the successful tenderer with the NIPGR.
