## TERMS AND CONDITIONS

**Name of work:** Anti -Mosquito fogging at NIPGR Campus, New Delhi.

1. The site of work is at NIPGR Campus, Aruna Asaf Ali Marg, and New Delhi – 110067.
2. The rates shall be inclusive of all Fogging Materials, Fuel cost, labour etc.all other charges and all taxes including VAT & service charge and nothing extra will be paid.
3. The contractor shall arrange all T&P and nothing extra will be paid.
4. The fogging will be carried out fortnightly or as per time schedule given by Engineer-in-charge time to time.
5. The payment shall be made after Fogging on monthly basis.
6. The contractor shall follow all labour laws as prevailing in Delhi.
7. Nothing extra will be paid towards Transportation, handling, loading, unloading.
8. The work shall be carried out to the satisfaction of Engineer-In-Charge.
9. The contractor shall take all safety precautions to safeguard the health of inhabitants.
10. Deduction on account of TDS and other statutory deduction shall be made.
11. The rates shall remain valid for one year after issue of work order so as to continue the work order if so desired by the institute.
