- 3. The rates are inclusive of Transportation/travelling, lodging/boarding, loading, unloading & handling and nothing extra will be paid.
- 4. The rates shall be inclusive of VAT, Octroi, and all other type of taxes etc., and nothing extra will be paid. The Institute is exempted from payment of Service Tax. The quotationer quotes the item rate excluding Service Tax.
