TERMS & CONDITIONS

SUB.: Repairing of Automatic air shower system installed at Plant Growth facility in NIPGR, New Delhi.

- 1. The site of work is at NIPGR Campus, Aruna Asaf Ali Marg, New Delhi 110067
- 2. The payment shall be made after supply of material & completion of work. No advance payment will be made.
- 3. The quotationer must visit the site before quoting the rates and make himself acquainted with Automatic air shower system. The Institute shall entertain no extra claim later on
- 4. The rates are F.O.R. destination at NIPGR Campus, New Delhi and inclusive of all incidental charges towards transportation, loading, unloading and handling charges, etc., and fixing & installation of items and nothing extra will be paid on any account.
- 5. The rates are inclusive of VAT, other taxes, Octroi, etc., and nothing extra will be paid. The Institute is exempted from payment of Service Tax. The item rates are exclusive of Service Tax.
- 6. The work shall be completed within 14 days after the issue of work order. In case the work is not completed within stipulated period compensation @ 1% per day subject to maximum of 10% of work order amount shall be paid by the agency. The decision of the Engineer-in-charge shall be final & binding on contractor.
- 7. Testing & Commissioning of the system will be done in the presence of Engineer-in-Charge or his authorized representative.
- 8. The agency must have experience in the field of Automatic Air Shower System installation and repairing. The agency shall submit copies of work experience along with the quotation.
- 9. A quotation must be accompanied with EMD amounting to Rs. 1250.00 (Rs. One Thousand Two Hundred & Fifty Only). The EMD shall be in the form of demand draft of scheduled banks, drawn in favor of "Director, NIPGR" New Delhi.
