- 1. The site of the work is at NIPGR Campus, Aruna Asaf Ali Marg, New Delhi-110067
- 2. The quotationer must visit the site before quoting the rates and make him acquainted with the topography of the site. The Institute shall entertain no extra claim later on.
- 3. The rates are inclusive of Transportation/travelling, lodging/boarding, loading, unloading & handling and nothing extra will be paid.
- 4. The rates shall be inclusive of VAT, Octroi, etc., and nothing extra will be paid. The Institute is exempted from payment of Service Tax. The quotationer quotes the item rate excluding Service Tax.
- 5. The agency shall make own arrangement for the security of the material at the site.
- 6. The agency must get the prior approval of the material from the Engineer-In-Charge.
- 7. The agency shall have to arrange his own tools & plants including skilled & non-skilled manpower, welding machine, testing apparatus etc. required for execution of work and nothing extra will be paid.
- 8. The payment shall be made after completion of work; no advance payments will be made.
- 9. The work must be completed within 20 days after the date of issue of work order. In case the work is not completed within stipulated period, a compensation 1% per day subject to maximum of 10% of the work order amount shall be levied.

- 11. Testing & Commissioning of the installation will be done in the presence of Engineer-in-Charge or his authorized representative.
- 12. The data shall be provided for guidance to the contractor. The work shall be executed as per latest working drawings to be prepared by the contractor after award of work and submitted to the Engineer-in-charge for approval including any changes as may have been suggested by the Engineer-in-charge as required. The exact dimensions, location, distance & levels etc. shall be governed by the space conditions. After completion of work, the contractor shall have to submit Schematic Drawing, contractor wiring drawing and detailed BOQ for all Labs.
- 13. The cable must be megger tested before and after laying. Test reports for the cable shall be submitted in proper manner.
- 14. In case agency fails to do the work, the EMD of the agency shall be forfeited.
- 15. The work shall be executed by the electrical contractor having electrical license to execute the electrical work in CPWD/PWD/Railways/P&T Dept. or any scientific institutions.
- 16. The work shall be carried out as per CPWD specifications and to satisfaction of the Engineer -In Charge. The agency shall also follow all labour laws as prevailing in Delhi.
- 17. The agency must have experience in the field of similar works. The agency shall submit copies of completion certificate of three similar works each of value not less than 2.95 lakhs or two similar


