1. The contractor should visit the site and make them self-acquainted with the location of site. The Department shall not entertain any extra claim later on.
2. The site of work is at NIPGR Campus, Aruna Asaf Ali Marg New Delhi-110067.
3. The contractor shall make his own arrangement for the security of material at site.
4. The contractor shall arrange all T&P and nothing extra will be paid.
5. The contractor must get the prior approval of materials from the Engineer- In –Charge.
6. The rates shall be inclusive of Transportation, loading, unloading and handling charges of material and nothing extra will be paid
7. The rates shall be inclusive of all taxes including VAT & Service tax.
8. The contractor shall follow all labour laws as prevailing in Delhi.
9. All works shall be completed to the entire satisfaction of the Engineer-in-charge.
10. The Institute reserves the right to reject / accept any or all quotation without assigning any reason.
11. The Institute also reserves the right to reduce / increase the scope of work to a maximum of 50%.
12. In case of any dispute the decision of the Engineer-in-charge shall be final & binding on the contractor.
13. Any work not carried out as per instructions of the Engineer-in-charge shall be dismantled and reconstructed by the contractor without any extra cost.
14. The work shall be completed in all respects within **15 days** after the date of issue of work order. Being a time bound, contract, and the contractor shall be liable to pay penalty @ 1% per day subject to maximum of 10% of quoted amount if the work is not completed within stipulated time of Completion.
15. The Contractor shall be responsible for any damages and site clearance and nothing extra will be paid. In case the site clearance is not attended, a recovery amounting to Rs. 2500/- (Two thousand & Five hundred only) shall be made. The damages, if not attended shall be carried out at the risk & coat of the agency.
16. The quotation must be accompanied with **earnest money deposit (EMD)** of amounting Rs1020/-(Rs. One Thousand and Twenty only). The earnest money shall be in the form of DD of scheduled bank drawn in favour of “**Director NIPGR**” New Delhi. **Without EMD quotation will not be accepted.** If a tenderer on his own withdrawn\or revokes the tender for any item or condition in the tender

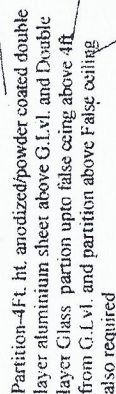
