TERMS & CONDITIONS

Name of Work:

Supply, Installation, Testing and Commissioning of 4 nos. Butterfly valves 250 mm gear operated for primary pumps of chillers for main building at NIPGR, New Delhi.

- 1. The agency must visit the site to get well aware of the site of installation of valves. The site of work is at NIPGR Campus, Aruna Asaf Ali Marg, New Delhi 110067.
- 2. The rates are inclusive of Transportation, loading, unloading & handling charges and nothing extra will be paid.
- 3. The rates are inclusive of VAT, other taxes, octroi, etc., and nothing extra will be paid.
- 4. The contractor shall make his own arrangement for the security of material at site.
- 5. The contractor shall arrange all T&P and nothing extra will be paid.
- 6. The rates are all inclusive of the material required and nothing extra shall be paid, if required during installation.
- 7. The tender must be accompanied with EMD amounting to ₹ 3,000.00 (₹ Three thousand only) by way of Demand Draft in favour of Director NIPGR, New Delhi. The EMD shall be adjusted towards Security Deposit.
- 8. The tender not accompanied with EMD will not be considered.

Manufacturer's warranty shall also be submitted in original.
- 20. Any minor alteration/ modification/Civil works shall be done free of cost by the contractor eg. Cutting & refixing of glass, breaking & repairing of wall in good manner etc.
- 21. The agency must get clear to the size and make of installation of valves. If, during installation, the valves supplied by the agency does not get fitted as per existing installation, nothing extra shall be paid and agency shall be required to supply the valves compatible as per existing installations.
