Technical Specifications

- 1. The system should be a triple block format, 0.2 ml independent control Thermal Cycler with separate peltier blocks to provide independent temperature zones.
- The system should accommodate 50 well or less in each block.
- 3. It should allow up to 2 to 3 experiments to be run simultaneously and completely independent of each other without interference.
- The system should be able to connect via mobile for convenient remote access.
- The system should have flexible block configuration, Different blocks can be fitted into the base module of
- On board Tm calculator facility to approximate the optimal annealing temperature.
- The system should support PCR volumes ranging from 10 to 80 μl.
- Display Interface can be at least 8.0" color TFT LCD.
- Maximum block ramp rate should be atleast 6.0°C/sec
- Maximum Sample ramp rate should be >4.0°C/sec
- 11. Temperature accuracy should be atleast ±0.25°C
- 12. Temperature range should be between 0°C to 100.0°C
- 13. Temperature uniformity should be +0.50 °C well to well within 30 sec of arrival at 95 °C
