- 1. The tender document can be obtained from our Office on payment of ₹ 500/- (Rupees Five Hundred only) from 23/1/2018 to 09/2/2018 (01:00 P.M.). The tender document is also available on https://eprocure.gov.in and can also be downloaded free of cost from our website www.nipgr.ac.in.
- 2. Every tender shall be accompanied with the required Earnest Money Deposit in the form of Demand Draft drawn in favour of the "Director, NIPGR" payable at New Delhi. Any tender not accompanied by such earnest money will be rejected straight away.
- 3. The rates quoted in the tender shall remain valid for a period 180 days from the date of issue of Award Letter. No tenderer can withdraw/or modify his tender or revoke the same within the said period. If a tenderer on his own withdraws or revokes the tender or revises or alters or modifies the tender for any item or condition within the period mentioned in the tender notice, his earnest money deposit shall stand forfeited.
