Technical Specification

- Filter based Luminometer with PMT has detector for maximum sensitivity.
- Should have up to six filter positions in the filter wheel.
- Should have wavelength range from 270nm to 670nm.
- Should have orbital plate shaking capability.
- Quote all the optional filters available for the system.
- System should have best sensitivity of 10 amol ATP/well using flash reaction, white 384 well plate.
- Should be compatible for 1 384 well plate format.
- Should have automatic calibration before each reading.
- Luminometric Dynamic Range should be >9 decades over whole gain setting area
- Should have at least 15 second reading speed for 96 well.
- Fiberless direct illumination optics for both top or bottom reading.
- Inbuilt incubation upto 45 °C should be available.
- Plate Shaking option with Orbital method, speed 60 1200 rpm
- Instrument should have certification for CE/ Europe regulations.
- Can be able to upgrade up to 3 dispensers for the flash luminescence.
- System should be supplied with Computer and Analysis software with unlimited user license.
- Upgradation options:
- Option for on-board dispensers, dispensing volume should be 1 µl to 1000 µl with 1 µl increments.
- Should have option for 3 or more dispensers for Flash assays like calcium flux and ATP assays. Simultaneous dispensing and measurement enables assays such as, Ca2+ flux measurements and fast kinetic assays.
