Sealed Tenders are invited on behalf of Director, NIPGR from the Original Equipment Manufacturer or their authorized dealers for the purchase of 01 no. of Gel Documentation System for the laboratory of our Institute, as per the following specifications:.

Technical Specifications

- High resolution scientific grade ultra peltier cooled CCD camera with at least 4.0 million pixels with true 16-bit depth. This
 should be a feature of the camera hardware and not through software manipulation.
- Equipped with motor driven fixed lens feedback system for storing and reproducing settings like focus, minimum cooling range of -30°C below absolute temperature, quantum efficiency and lighting exposure time.
- Darkroom should be light tight for advanced chemiluminiescence, fluorescence, and visible light applications, and equipped with electronic and automatic door lock with a security function to prevent interruption to long exposure.
- Five position filter wheel with filters for visualization of stains like fluorescent stains (ethidum bromide), coomassie blue, pink and silver stains, ProQ diamond, deep purple, sypro ruby, and sypro orange, etc.
- Should be capability of visualizing the stain-free gel and multiplexing of different dyes and equipped with dynamic flat fielding.
- UV lighting System employing equipped with 302 nm, image viewing area not less than 25 x 25 cm with control of variable intensity, UV-to-white light converter for viewing protein gels and for other white light applications.
- Automatic application driven software to capture the image automatically for ID gel analysis with automatic band matching and free lifetime up gradation. Software must have a GLP compliant format.
- 8. Automated software for analyzing 1D gels, 2D Spot blots, Egels, Multi-layer gels (multiple well lines per gel), colony counting and band matching, and should have option for automatic normalization of proteins. It should have single window for simultaneous display of all data, images, and histogram. Software should have direct link to Excel and Word to display data in a variety of different ways, dendrograms, matching coefficients and matching matrix.
- The system should be supplied with a branded computer having system configuration (Intel i5-i7 processor, 4-16 GB RAM, 1 TB hard disc, 21-24" wide-screen TFT/LED monitor and licensed version of Windows 8 or 10 Professional) and 2 KVA online UPS of standard make for visualizing and analyzing the gel images.
- The manufacturer should have installation such instruments in different research laboratories within India (need to enclose list of installation along with detail address and contact numbers).
- 11. System must have comprehensive warranty of at least one year and need to provide continuous service and application support back-up for effective application-related troubleshooting of the instrument.

You are therefore requested to please send your offer in two bid system indicating the maximum discount offered, installation charges along with a copy of authorization certificate, issued by the Principals/CEM. The quotations must accompany a Demand Draft amounting to ₹ 24,000/- (Rupees Twenty Four Thousand only), being the EMD in the name of Director, NIPGR, New Delhi and must be sent in a Sealed Envelope duly super-scribed on top of envelope as "Quotation for Gel Documentation System" so as to reach to the undersigned latest by 23/9/2015 (3:00 PM), the same shall be opened on same day at 3.30 PM.

- Every tender shall be accompanied with the tender cost of ₹ 500/- (Rupees Five Hundred only) in the

 sealed envelope along with the tender. In case the tender cost is not submitted, the tender will not be
 considered.
