Sealed Tenders are invited on behalf of Director, NIPGR from the Original Equipment Manufacturer or their authorized dealers for Supply, Installation, Testing & Commissioning of **01 no. of Autoclave** for our Institute, as per the following specifications in single bid system.

**Technical specifications:**

- The autoclave must have a capacity of minimum 50 Liters
- The autoclave should be vertical with microprocessor based controller and featured with PID Display PV & SV 16x2 character LCD display
- Heating element should be ISI marked.
- The autoclave should be fully automated with high alarm set
- Boiler should be doubled walled and made up of stainless steel
- The working pressure adjustable from 10 psi to 20 psi  $\pm$  3 psi.
- Double walled Boiler is made of 18/8 stainless Steel
- The boiler dimension should be around 350 x 550 mm.
- Outer wall should made of stainless steel 304 grade, 1.0 mm thick Lid 10mm single pc thick 304 grade and made of stainless steel provided with radial locking systems, worked by a handle.
- Gasket should be of silicon rubber hydraulically tested up to 40PSI
- Autoclave should be provided with stainless steel basket with low water cut off floating type.
- It should operate in 230 volts AC only

You are therefore requested to please send your offer in **single bid system** indicating the maximum discount offered, installation charges along with a copy of authorization certificate, issued by the Principals/OEM. **The cost of the equipment and taxes should be quoted separately in the Bid.** The quotations must accompany a Demand Draft amounting to ₹ 1,200/- (Rupees One Thousand Two Hundred only), being the EMD in the name of Director, NIPGR, New Delhi and must be sent in a **Sealed Envelope** duly super-scribed on top of envelope as "**Quotation for 01 no. of Autoclave**" so as to reach to the undersigned latest by **09/9/2019 (3:00 PM)**, the same shall be opened on same day at **3.30 PM**.

The tender document downloaded from the website is exempt from payment of tender document cost (₹ 150/-).
- The rates quoted in the tender shall remain valid for a period 90 days from the date of opening of Tender. No tenderer can withdraw/or modify his tender or revoke the same within the said period. If a tenderer on his own withdraws or revokes the tender or revises or alters or modifies the tender for any item or condition within the period mentioned in the tender notice or fails to perform as per work order or violates any condition of tender, the security deposit/ performance security will be forfeited/encashed.
